Editorial

Dear colleagues,

According to a new report published by the UNHCR under the title "[Desperate Journeys](#)", despite the fact that the numbers of refugees and migrants reaching Europe last year have dropped, the dangers many of these people face along the way have increased in some cases. "Search and rescue is a humanitarian imperative and must remain a top priority. If human beings are in distress at sea, the question is not about their status, but rather saving lives" (Volker Turk, UNHCR Assistant High Commissioner for Protection, 06 July 2017).

So far 489 deaths have been reported at sea this year compared to 870 in the first three months of last year" (UNHCR, January 2017 – March 2018).

The need to increase solidarity among the Member States of Europe and countries of first asylum and transit is imminent. This will help towards enhancing the quality of reception, especially for unaccompanied and separated children and survivors of sexual and gender-biased violence.

Taking into consideration the above evidences, the Mediterranean Migration Network, coordinated by the international Research Centre **CARDET**, and the **SME INNOVADE**, continues its activities and actions towards providing support to stakeholders who are called to delegate migration and integration issues daily.

The study visit to Rome, Italy, was attended by 7 delegates of Cyprus public services, local authorities and NGOs. Italy is one of the main landing points for migrants who cross the Mediterranean. Over the last 10 years, while as a country has managed to absorb hundreds of thousands of migrants (especially from Africa).

E-COURSE

Enhancing the Participation and Learning Performance of Migrant and Refugee Children in Primary School Education

E-COURSE is a two-year Erasmus+ project (October 2017 - September 2019) which aims at enhancing the access, participation and learning performance of newly arrived migrant and refugee children in primary school education in seven European countries: Germany (IMA), Greece (KMOP), Italy (CESIE), France (Pistes Solidaires), Holland (ESHA), UK (Canary Wharf Consulting) and Cyprus (CARDET) in order to promote their overall integration in the host societies.

For the purpose of achieving the above during the implementation of the project, the project partners will develop "*Learning modules for strengthening the capacities of teachers*" and implement at the beginning of the school year 2018-2019 a series of face-to-face workshops to teachers and school leaders in order to provide them with the necessary knowledge so to be able to effectively address equity, diversity and inclusion challenges in the learning environment in primary schools. The partners had interesting discussions about the ways of reaching migrants / asylum seekers to let them know of the project's aims in order to take the interviews and conduct the focus group discussions to develop an effective "Orientation and Counselling Handbook". In addition, partners reviewed the modules and reflected on the possible future challenges during the piloting implementation sessions and ways of resolving them. Partners had interesting inputs in relation to the interviews they had conducted already and shared the target audience's opinions. The consortium is now looking for migrant employers / migrants who successfully found a job in the hosting countries to participate in networking sessions in order to provide their suggestions. The "BACKPACK ID" project, is an innovative intervention for promoting the inclusion of refugee children at school in 4 European countries (Greece, Italy, Germany and Sweden), which are met with acute and very diverse challenges by the ongoing refugee crisis. Informed by these differences, the present approach on

social inclusion advances a common account of social inclusion challenges; it sees the social inclusion of refugee children as a function of addressing the needs and perspectives of those children and their families, and local communities and stakeholders, while affirming common European values.

Backpack team is working towards finalizing the content of the E-book along with the video production of a collection of videos that will be developed based on the students' personal stories and contribution.
